Bennett Staff Terms and conditions for "Client Christmas Charity Donation "

Prize Draw

1. The Promotor

2. The Competition

2.1 The title of the competition is "Client Christmas Charity Donation!" - Prize draw to donate £100 to the chosen charity of your choice".

2.2 The competition will run from Wednesday 8th of November until Wednesday 6th December 2023.

2.3 The winner of the Competition will be chosen by way of a random prize draw that will take place on Thursday the 7th December 2023. The winner will be selected at random by Bennett Staff.

3. How to enter

3.1 You will be eligible to enter into the competition when you complete a form on our website:

3.2 In this form we will ask you to tell us how we can improve our services. You must also include contact information and some personal details.

3.3 Upon completion of the form you will receive a thank you message on screen and will be added to the prize draw. There is a limit of one entry per individual.

3.4 All competition entries must be received by Bennett Staff by no later than the closing date advertised (6th December 2023). If your entry is received after this cut-off date, your entry shall be automatically disqualified.

3.5 Bennett Staff will not accept responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any online platform or internet failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.

3.6 By submitting a competition entry, you are agreeing to be bound by these terms and conditions.

4. Eligibility

4.1 You must have submitted the form with your correct contact details in accordance with condition 3.2.

4.2 The competition is only open to all residents in the UK aged 18 years or over, except:

4.2.a employees of Bennett Staff or its holding or subsidiary companies;

4.2.b employees of agents or suppliers of Bennett Staff or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or

4.2.3 members of the immediate families or households of (a) and (b) above.

4.3 In entering the competition, you confirm that you are eligible to do so and eligible to claim the prize. Bennett Staff may require you to provide proof that you are eligible to enter the competition.

4.4 Bennett Staff will not accept competition entries that are:

4.4.1 automatically generated by computer;

4.4.2 completed by third parties or in bulk

4.5 Bennett Staff reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.

4.6 Competition entries cannot be returned.

4.7 You must have used Bennett Staff in the last 12 months.

5. The Prize

5.1 The prize will be a donation of £100 to the clients chosen charity.

5.2 The prize is not negotiable or transferable or refundable.

6. Winner announcement

6.1 The winner of the competition will be announced on our website (<https://bennettstaff.co.uk/>) within a reasonable time following the competition closing date (6th December 2023). There will only be one winner for the competition.

6.2 The decision of Bennett Staff is final, and no correspondence or discussion will be entered.

6.3 Bennett Staff will contact the winner personally as soon as practicable after the Announcement Date, using the contact details provided with the competition entry. Bennett Staff will not amend any contact information once the competition entry form has been submitted.

6.4 Bennett Staff may publish the name of winner on their website and social media.

7. Claiming the prize

7.1 Bennett Staff will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their prize within 7 days of the date of the draw, Bennett Staff reserves the right to offer the prize to the next eligible entrant selected from the correct entries that were received before the draw date of the Competition.

7.2 Bennett Staff does not accept any responsibility if you are not able to take up the prize.

8. Limitation of liability

As permitted by law, Bennett Staff its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of Bennett Staff, its agents or distributors or that of their employees. Your statutory rights are not affected.

9. Ownership of competition entries and intellectual property rights

9.1 All competition entries and any accompanying material submitted to Bennett Staff will become the property of Bennett Staff.

9.2 By submitting your competition entry and any accompanying material, you agree to:

9.2.1 assign to Bennett Staff all your intellectual property rights with full title guarantee; and

9.2.2 waive all moral rights, in and to your competition entry and otherwise arising in connection with your entry to which you may now or at any time in the future be entitled under the Copyright, Designs and Patents Act 1988 as amended from time to time and under all similar legislation from time to time in force anywhere in the world.

9.3 You agree that Bennett Staff may, but is not required to, make your entry available on its website <https://bennettstaff.co.uk/> and any other media, whether now known or

invented in the future, and in connection with any publicity of the competition. You agree to grant Bennett Staff a non-exclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights in the competition entry and any accompanying materials, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry and any accompanying materials for such purposes.

11. General

11.1 If there is any reason to believe that there has been a breach of these terms and conditions, Bennett Staff may, at its sole discretion, reserve the right to exclude you from participating in the competition.

11.2 Bennett Staff reserves the right to hold void, suspend, cancel, or amend the prize competition where it becomes necessary to do so.

11.3 These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
